This is a historical moment to acknowledge this country has a dark side and dark history; this national dream is unfinished, and the only way forward is through acknowledgement and working together and this Board pledges its commitment to this. Her Worship Mayor Therrien has been a leader in this community fighting for indigenous rights. Mayor Therrien encourages all to look at the Truth and Reconciliation Report, the Royal Commission of Aboriginal People Report, the Ipperwash Report and the Missing and Murdered Indigenous Women and Girls Report. The last residential school closed in 1996; this is not history, this is lived present. Mayor Therrien asks that people take the time to read the executive summaries and calls to action and take the time to reflect.
